Notice is hereby given to all Members of Placido Bayou Community Association, Inc. (the Community Association") that at the Annual Meeting of the Community Association, which will be held on June 18, 2013 at 6:30 p.m. in the Community Association Office at 4691 Laurel Oak Lane, St. Petersburg, the Board of Directors of the Association intends to vote on a proposal to preserve the Master Declaration of Covenants, Restrictions, and Easements for Placido Bayou (the "Master Declaration") dated September 11, 1984 and originally recorded in Official Records Book 5848, Page 1477 of the Public Records of Pinellas County, Florida, as has been amended from time to time.

Copies of the Master Declaration and other governing documents of the Association can be found on the "PBCA Governing Documents" page of the Association's website, www.pbca.info.
